CREDIT AGREEMENT

In consideration of Southwest Corrugated, Inc. ("Seller") selling goods or services to the above named Credit Applicant (herein called the "Buyer"), from time to time. Buyer agrees, with respect to all purchases made by Buyer as follows:

- Buyer agrees to pay all amounts in full within thirty (30) days from the date such amounts are billed ("Payment Due Date").
- Seller may charge interest at the rate of one and one-half percent (1 1/2 %) per month on all amounts remaining unpaid at the Payment Due Date.
- If Buyer does not pay all amounts on or before the Payment Due Date, Seller, at its option, immediately or at any time thereafter, may terminate its obligation, if any exists, to extend credit hereunder.
- If Buyer's account is placed in the hands of an attorney for collection after default hereunder, or for the purpose of being sued upon or established in any manner in any court, then in any of said events, Buyer agrees to pay reasonable attorney fees, court costs and disbursements in addition to all other sums owing hereunder.

Nothing herein shall entitle the Seller (or any other holder thereof) to contract for, charge or receive interest hereon in excess of the maximum permitted by applicable law. In the event any interest in excess of the maximum permitted by applicable law is contracted for, charged or received by any holder, all such excess interest shall, at the sole option of the holder, be refunded to Buyer or credited against the amounts lawfully owing hereunder.

This agreement shall be governed by the laws of the State of Texas.
